Planning Report

Performance of the Planning Sub-Committee over the past year has been hampered somewhat by illness affecting key members. Despite this, there has been considerable progress on many fronts, many of which will lead to key questions being addressed by members concerning the Society moving forward.

Planning Applications Overview

The downward trend in the volume of larger scale development applications, has continued; with most of the developments around the fringes of Deal, Walmer, and the local villages having been approved pre-COVID: but only now are we seeing their (ugly?) face.

Most applications are now minor, and single property specific in nature, and it is unusual to see anything larger though there are a few, which I will refer to shortly.

Planning Network, broadening community knowledge and involvement

The information on planning, on the planning system, on evaluating planning proposals, etc. has been greatly expanded on the DS website and we've been encouraging people to refer to/use it.

We have provided steering, guidance, and advised on other expert sources of knowledge/experience, that has helped those who have been campaigning to save the Fairfield in Gt Mongeham from development.

We have collaborated with the Reopen the Regent campaign on responses to the latest proposals to develop the site; submitting a response of our own, and providing key intelligence on some of the key planning issues for others to consider.

From the linkages around Fairfield, we have learnt about new measures in the Dover DC Local Plan, specifically relating to Deal and its environs, "to prevent Deal absorbing nearby separate entity villages"...... though I'm sure many in Sholden, Mongeham, and Upper Walmer in particular will feel that comes a bit too late for them.

This link demonstrates the importance of networking: much more needs to be done to secure that.

Current sites of concern

Two development proposals concern Northwall Road, close to the railway crossing, but also bordering the flood plain for the area which is already under strain from all other development around Sholden. One is for 44 houses, the other for 6; no infrastructure, access, traffic volume, are other issues.

The Local Plan anticipates a development of 75 houses in Kingsdown, which local residents do not want to see happen; an initial planning application has gone in to DDC.

Perhaps the biggest threat comes in Deal Town Centre where there are prospectively 6 sites being redeveloped, and no overarching strategy to ensure these are considered collectively and their cumulative impact on the Town Centre all are in the Middle Street conservation area.

Conservation area assessments

Deal & Walmer have 7 conservation areas between them, and DS has played a major role in the assessments of these areas, and in the associated planning guidance that stems from them.

The most recently completed by the DS was Upper Walmer, which was pre-COVID, and only now are DDC considering its implementation.

Growing problem is that the expertise on conservation assessments is concentrated in just 2 planning sub-committee volunteers who are getting no younger; and if the DS is to be able to continue this role of direct community involvement in shaping their conservation areas, it needs to develop new volunteer resources with those skills across the 7 areas.

Local Government reform and re-organisation

The new government is in the middle of bringing about the largest change in Local Government and how it is geographically organised, in more than 50 years: the challenge is to create new structures that are fit-for-purpose, efficient and effective In place of public services badly neglected.

The number of Local Authorities will reduce, in favour of unitary authorities (most with Mayors), which in Kent could bring about 4 areas rather than the current 10 districts, plus a major overhaul of the roles of Town & Parish Councils.

What that means for us in Kent is subject to conjecture, but we have taken steps to join with other Amenity associations in East Kent (through an East Kent Civic Forum) to try to align civic action as well as influence new structures we need to keep ahead of the game.

However, irrespective of the outcome of that reorganisation, it does not mean that the planning function will necessarily mirror that; but we must hope that such decisions are not taken too far away from being relatively local or we risk not being able to influence those decisions.

In the meantime, the important link that DS has with the Deal Town Council Planning Committee must be maintained in the best interests of heritage protection and reasonable developments; and seek to secure similar integration with whichever future structure replaces it.

Improved Communication internally and externally

Expanded Newsletter, with wider-ranging issues from across the town: targeted use of social media (with thanks to Ron)

Seeking to include input from individual planning campaigns across the area, sharing information and intelligence

Collaborating with other bodies that have newsletters or who have social networks that reach out across different groups within the community

Mutually beneficial placing of articles in other(s) publications

Challenges aheadto summarise

Local residents placing too much reliance on DS as policing developments, but they need to realise that it is everybody's job and responsibility..... and not just when an issue arises they don't like

No overview to Deal Town Centre changes, so need to raise awareness (Town Council are beginning to realise the risks, but we should perhaps, lead on a public debate on the issue?)

Increasing and spreading the skills around conservation area assessment, including "champions" in each area

Strengthening networking to ensure we access all key data and intelligence (e.g. Planning Inspectorate involvement with The Regent)

Helping to create a stronger History Alliance, that brings all with expertise to contribute to how Deal and Walmer's history and heritage is depicted, and

Ideally having such a group acting within a wider network of bodies that together present our history and heritage holistically, within a very relevant current day context say, illustrating and understanding our past, identifying and promoting our heritage, spreading knowledge of how this manifests itself in the area today in both our buildings and our communities, why conservation areas are so important in planning and regeneration, protecting the heritage yet still enable needed development: that means Deal Society, Deal Museum, Time Ball Tower etc. working strategically together, and engaging/informing wider social networks that our people regularly use.

Report on last year

Civic Matters

We are a member of Civic Voice which raises concerns from civic societies nationally. We are also part of an emerging initiative, East Kent Civic Forum, to improve cooperation between local societies.

We continue to support Walmer Town Council with Walmer In Bloom.

Communication

A year has gone by since we last produced a printed report, we are committed to maintaining this contact for those who don't have email, but more frequent updates are available through our electronic newsletter and social media.

Heritage

The society continues to co-organise Heritage Open Days, England's biggest heritage festival, in conjunction with the Deal and Walmer Town Councils.

The event takes place each September and all venues are free to explore, offering people the chance to see hidden places and try out new experiences.

Our activities have returned to pre-pandemic levels and we continue to try to improve the event with new ideas.

We are also part of the Deal History Alliance, which includes local organisations and individual historians with the aim of improving the communication between them and to generate year-round interest in our history.

The alliance organised a number of drop in history sessions to introduce new people to our heritage.

The society maintains the Deal Heritage website to promote local heritage events, together with our social media and newsletter.

As with other parts of the society, these initiatives need additional help.

Finances

In 2024 we had an income of £4,939 and expenditure of £5,601, giving a deficit for the year of £662. At the end of the year the funds held were £6,469.

The cost of running the society was similar to the previous year but donations were down by about £100. Social events are budgeted to break even but for various reasons made a loss.

The deficit does not raise any concerns as the reserves equate to 5 years running costs, which is why we did not make any appeal for donations during the year.

The story of the Cinque Ports is a fascinating tale of how a few settlements by the sea rose to become towns of such wealth and influence that they could threaten the King's power.

From Anglo-Saxon times, well before the days of the Royal Navy, the Cinque Ports provided the men and ships to defend our shores and to protect their lucrative trading links, but they were an unruly group who had little regard for rules.

After centuries of strength many of the towns declined into obscurity, but the confederation still exists and David White will tell the story of the rise and fall of this historic institution.
